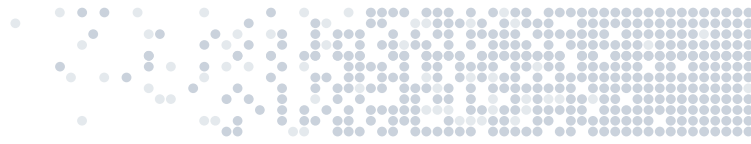

The applicant is an existing Registered Training Organisation with current student numbers of 105. The RTO receives Smart & Skilled funding, is not registered for VET Fee Help/VET Student Loans.

The RTO business currently provides training in the following qualifications:

- UEE32211 Certificate III Air-conditioning and Refrigeration
- UEE30811 Certificate III in Electrotechnology Electrician
- MEM30305 Certificate III in Engineering – Fabrication Trade
- UEE20111 Certificate II in Split Air-conditioning and Heat Pump Systems
- UEE21911 Certificate II in Electronics
- UEE22011 Certificate II in Electrotechnology (Career Start)

The Applicant is seeking approval to offer the same scope to overseas students with a maximum overseas student capacity of 100.

The Applicant does not plan to use Education Agents or offer enrolment to under 18s and will not offer work based assessment.

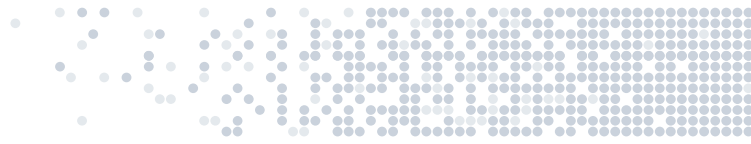
